Analyzed data from a series of education PETS to discover determinants of leakage and to evaluate the impact of an information

campaign on leakage, enrollment and learning. Published peer-reviewed journal articles in the *Quarterly Journal of Economics*, *Journal of the European Economic Association*, and *Journal of Public Economics*.
