Description of Responsibilities

Under the direct supervision of the Digital Design Associate and Webmaster, and the overall supervision of UNU-WIDER's Communications Team Lead, the Website management Intern will be performing the following duties:

- Support the day to day administration and management of the UNU-WIDER websites
- Implement the house style and lay out best practices on each site accordingly
- Accept and document incoming web related requests, setting realistic timelines with supervisor for the work, and monitoring the progress of the different projects
- Support the coordination of tasks and products with supervisor and members of the larger unit
- Support procurement and other administrative processes related to the management of UNU-WIDER's web presence
- Other duties assigned by supervisor

Learning objectives

The intern will be part of the communications team and the overall Knowledge Mobilization Unit of UNU-WIDER

and will be learning on the job daily. Dedicated time will be allocated by the supervisor for understanding the brand, styles and web ecology of UNU-WIDER and the UN system in general, and the role of web management in knowledge mobilization. The intern will gain insight to the functioning of a UN think tank from a online communication perspective, while learning how to work within the UN and UNU visual identity, rules and regulations.

The intern will be able to participate in training offered by UNU-WIDER and opportunities will be discussed with the intern upon arrival. No travel missions are foreseen from the outset.

Qualifications

Education:

Applicants to the UNU-WIDER internship programme must at the time of application meet one of the following requirements:

- University studies in one of the following disciplines: Graphic Design, Design and Visual Communications, or other relevant subject.
- Have graduated with a university degree in relevant discipline such as Social Sciences, International Studies, Business Administration, other related field and, if selected, must start the internship within two years of graduation.

Language:

- Excellent communication skills (written and oral) in English are required;
- Working knowledge of another UN language is an advantage.

The Intern is expected to have:

- The ability to work in a multi-cultural environment with sensitivity and respect for diversity;
- Working knowledge and experience in using Drupal or other website management tool, MS Office
- Experience and basic knowledge in using Photoshop

- Experience with video editing is an asset.
- Experience with Adobe InDesign, Illustrator and Premiere Pro is an asset.
- Understanding of HTML5 and CSS is an asset

Stipend

Interns who are not in receipt of financial support from other sources such as universities or other institutions will receive a stipend of EUR 896.00 per month of full-time internship from UNU to partially subsidize their basic living costs for the duration of the internship.

The stipend will be paid on a monthly basis and part-time internship arrangements are prorated accordingly.

Duration of contract: The duration of the internship is 6 months.

How to Apply:

To apply to UNU, you will not need an account. Instead, we ask that you:

- Apply via the application link;
- Attach a brief Cover Letter (in English) stating interest in and qualifications for the post;
- Attach a current and complete CV in English;
- Document(s) confirming your education status (e.g. transcript or proof of enrollment)
- Answer a few questions that are tailored to the internship.

Assessment

Evaluation of qualified candidates may include a desk review and/or a competency-based interview, and references.

Please note that the selected candidate must have a (1) Finnish nationality or the residence and work permit for Finland, OR (2) have right of residence in Finland as an EU/EFTA citizen. In case of equally qualified candidates, the candidates holding Finnish nationality or the residence and work permit for Finland will be given preference.

Interns do not hold international civil servant status nor are they considered a "staff member" as defined in the United Nations Staff Rules and Regulations and may not represent UNU in any official capacity.
